

B. Personal Data Processing Information

The Nicolaus Copernicus University in Toruń with its registered office at Gagarina 11 will be the administrator of your personal data.

Your personal data shall be processed pursuant to Article 6.1.(f) of Regulation 2106/679 of the European Parliament and of the EU Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data and on repealing Directive 95/46/EC (GDPR), i.e. in the legitimate interests including:

- efficient organisation of the call,
- deciding on the results of the call and awarding funding,
- possibility of establishing contact with the participants of the call.

Please note that if you have given your consent, you have the right to withdraw it at any time; however, this will not affect the processing that was carried out before the withdrawal.

The personal data provided by you will be kept until the date on which the possibility of pursuing claims in connection with the organization of the call ceases to exist, but no longer than 3 months from the date of deciding on the results of the call.

You have the right to request access to your personal data, to rectify, erase or restrict processing of your personal data, as well as the right to object to its processing.

Providing your personal data is voluntary, but refusing to provide it or objecting to the processing of your personal data will prevent you from taking part in the call and otherwise has no other effects.

You have the right to lodge a complaint with a supervisory authority.

Your personal data will not be passed on to other entities.

C. Instructions for calculating flat-rate funding costs

In the case of participation in the workshop **Plant-microbial interactions in saline areas** the number of days (including two additional days for departure and return, if necessary) is max. **7** days.

1. Allowance amount

The amount of the stipend depends on your status - it is PLN 75 per day for undergraduate and graduate students, and PLN 250 per day for foreign scientists.

2. Accommodation costs

Living costs depend on the country in which the mobility takes place. For activities based in Poland this amount is PLN 300 per day.

3. Travel costs

Travel expenses depend on the origin of the mobility. The amount to be added to the final result can be found in the table below.:

4. Calculation of total funding:
